If your manager understands what happened, they may be more likely to rehire you in the future. To be rehired at Walmart after you were terminated, you'll typically need to wait at least six months to reapply, though some stores prefer that former employees wait a full year.

Walmart Policies and Guidelines

First and foremost, hiring managers need to define the criteria in the rehire policy for determining the eligibility of a former employee who is a candidate for being rehired. With this criterion in place, companies should be able to accurately weigh the pros and cons of the specific candidate and decide if it's worth it to bring them back onboard.

Rehire Policy Guidelines

Former employees whose termination reasons involved policy violations, such as workplace violence, insubordination, discriminatory or harassing behavior, theft or embezzlement and any ethics violations, are not eligible for rehire.

Sample of a Rehire Policy | Legal Beagle

The faculty or staff member had a minimum of one year of continuous previous service as a regular faculty or staff member. The break in service is greater than one year. The length of the break was less than the length of service prior to termination.

Eligibility for Rehire Policy - Human Resources

An employer who will rehire workers needs to have a clear, objective selection method in place. The employer should assume that she will have to explain the rehire criteria to a judge or the EEOC to defend herself against a charge of discrimination. A collective bargaining agreement may specify which employees

will be rehired.

Policy Statement. Supervisors are responsible for determining whether a staff member is eligible for rehire each time the staff member terminates employment, whether voluntarily or involuntarily, and if any conditions exist that would affect the rehire eligibility process. Staff who leave Duke in good standing (break in service from a regular position due to resignation, layoff or, in some cases, discharge) and later want to return are eligible for consideration for rehire.
